The program is immediately after school so you do not need to do anything until time to dismiss at 5:30 p.m. No transportation is provided so you will need to designate someone to pick your student up promptly at 5:30 p.m. Pickup will be at the school building they currently attend.

This program is for all Pre-K through Grade 12 students at North Clay. Obviously students will be separated by age groups. Parents/guardians are welcome to attend academic sessions with their child/children if you desire to learn what the child is doing and/or needs help with.
