

**NORTH CLAY COMMUNITY UNIT #25 BOARD OF EDUCATION  
SPECIAL BOARD MEETING  
NOVEMBER 1, 2011**

The North Clay Community Unit #25 Board of Education met in a Special Board Meeting called by Darren Bailey, President of the North Clay Board of Education, at 6:30 P.M. on Tuesday, November 1<sup>st</sup>, 2011 in the North Clay District Office.

The purpose of the meeting was for student disciplinary cases (5 ILCS 120/2©(9))

President Bailey called the meeting to order at 6:30 p.m.

Roll call was taken with the following members present: Troy Britton, Cecil Cochran, Christine Erwin, Cara Rinehart, Darrell McKnelly, and Darren Bailey.

Members absent: Mike Worthey. Mike arrived at 6:42 P.M.

Others present were: Superintendent, Monty Aldrich, Principals, Carolyn Grahn and Julie Healy, Assistant Principal, Terry Irvin, and Sara Wilson-Bushur.

A motion was made by Britton, seconded by Rinehart, to enter into closed session for the purpose of:

a. Student disciplinary case (5 ILCS 120/2©(9))

Ayes: Cochran, Erwin, Rinehart, McKnelly, Britton, and Bailey. Nays: None. The motion carried.

A motion was made by Britton, seconded by McKnelly, to enter open session. Ayes: Erwin, Rinehart, McKnelly, Britton, Cochran, and Bailey. Nays: None. The motion carried.

Upon returning to open session, the following motions were made:

1. A motion was made by Cochran, seconded by Britton, that student identified as **11-01-11A** be found to have violated school rules and that he be expelled from North Clay Unit 25 School District beginning 11/01/2011 and ending at the end of the first semester of the 2012-13 school year. Further moved that the expulsion be stayed and that he be placed on school probation for that period. In accordance with the agreement to be signed by the student, his parents, and the administration, violation of school probation will result in imposition of the expulsion. Ayes: Rinehart, McKnelly, Worthey, Britton, Cochran, Erwin, and Bailey. Nays; None. The motion carried.

2. A motion was made by McKnelly, seconded by Cochran, that student identified as **11-01-11B** be found to have violated school rules and that he be expelled from North Clay Unit 25 School District for the remainder of the 2011-12 school year. Further moved that the expulsion be stayed and that he be placed on school probation for that period. In accordance with the agreement to be signed by the student, his parents, and the administration, violation of school probation will result in imposition of the expulsion. Ayes: McKnelly, Worthey, Britton, Cochran, Erwin, Rinehart, and Bailey. Nays: None. The motion carried.

3. A motion was made by Cochran, seconded by McKnelly, that student identified as **11-01-11C** be found to have violated school rules and that he be expelled from North Clay Unit 25 School District for the remainder of the 2011-12 school year. Further moved that the expulsion be stayed and that he be placed on school probation for that period. In accordance with the agreement to be signed by the student, his parents, and the administration, violation of school probation will result in imposition of the expulsion. Ayes: Worthey, Britton, Cochran, Erwin, Rinehart, McKnelly, and Bailey. Nays: None. The motion carried.
